**Additional Comments**

The 2018 Shaker Pointe at Carondelet Bonds were issued as draw down bonds. On the Schedule of Debt page, the issuance amount includes the full \$12,500,000 of the 2018 Shaker Pointe at Carondelet Bonds issued. As of December 31, 2018, \$4,079,329 of the 2018 Bonds had been drawn down. On the Schedule of Debt page, the Outstanding End of Fiscal Year amount of \$45,808,753 includes the full \$12,500,000 of the 2018 Shaker Pointe at Carondelet Bonds issuance while the amount actually outstanding as of December 31, 2018 is \$37,388,082, which includes the amount of the 2018 Shaker Pointe at Carondelet Bonds that had been drawn down, not the full issuance amount of the 2018 Shaker Pointe at Carondelet Bonds. On the Bond Information pages, the interest rate on the 2018 Shaker Pointe bonds is the sum of (a) the Spread and (b) eighty-two (82%) percent of LIBOR. The interest period for LIBOR is monthly. Spread is defined as (a) from the Closing Date until the first Payment Due Date occurring after the issuance of the certificate of occupancy for the Series 2018 Project Facility, three and fifteen-hundredths percent (3.15%) per annum; (b) thereafter until Stabilization is achieved, two and ninety hundredths percent (2.90%) per annum and (c) from and after Stabilization, two and sixty five one hundredths percent (2.65%) per annum. Stabilization means, as reasonably determined by the Holder as of the close of a fiscal year of Shaker Pointe no earlier than June 30, 2020, (i) Shaker Pointe's independent living facility located on the Land of which the Facility comprises a portion shall have achieved a minimum Debt Service Coverage Ratio of 1.45 to 1.00 excluding any impact of entrance fees and (ii) Shaker Pointe has a minimum one hundred ten (110) Days Cash on Hand.
